Outreach and Enrollment- Open Enrollment closed February 1 with a total of 23,770 people enrolled. This number continues to grow in Wyoming in comparison to 21,092 in 2015 and 11,970 in 2014. Three health center assister programs used an online reporting form created by the WYPCA to track their efforts. Here's what the Health Centers who reported accomplished:

- Submitted enrollment applications for 169 people**
- Facilitated 13 Medicaid applications**
- Answered the questions of 159 people**

The WYPCA is very pleased and proud of this hard work. These three programs also tracked how many people fell into the infamous Medicaid Gap. An infographic illustrating this data can be found below at the end of this newsletter.

Something new this year is the Health Center award and nomination process. 


Legislative Summary- The Wyoming Legislature began their work on February 8 for a short 20 day budget session. The Joint Appropriations Committee (JAC) met much of December and January to work on the budget submitted by Governor Mead.

The biggest reason to watch the budget this year was that Governor Mead included the cost and cost savings of Medicaid Expansion in the budget. His support for expansion was not shared by many on the committee and expansion was amended out of the budget during the JAC's January debate in spite of the number of Wyoming people who fall into the coverage gap (see infographic below). Other attempts through the session to reinsert Medicaid into the budget prior to its being adopted were unsuccessful. One budget footnote did appropriate \$1 million to begin a build-out of a multi-payer, statewide health information exchange.

Other bills of interest were two bills that approved a Nurse Licensure Compact, allowing Wyoming to enter into a compact with other states to allow nurses and N-Ps licensed in one compact state to exercise a multistate licensure privilege in other states that are a party to the compact. A bill to clarify some tenants of involuntary care (Title 25) passed and included language that allows for a single point of responsibility for a gatekeeper, who is designated by the department of health in consultation with the county. The gatekeeper coordinates, monitors and oversees payments for the Title 25 patients. Unsuccessful bills of note was Rep. Sue Wilson's bill on "Healthcare Access Improvement Grants", a takeoff on the Primary Care Support Program and a palliative care bill that would have set up a Governor-appointed task force to talk about care for people with serious illnesses focused on relief

Special Populations- Ag Worker Health & Services is the new clinic to serve as Wyoming's Migrant Health Center. It located at 149 North Bent Street in downtown Powell. Montana Migrant and Seasonal Farmworker Council Inc. oversees the program and recently received national recognition as a 'High Value Clinic' for the program in their home state. They recently hired Mary Freund FNP as their provider to begin services in late May. We are confident they will be able to replicate similar, successful results in Wyoming.

Expedited Partner Therapy Courtney Smith, MPH, CPH, CPM Wyoming Department of Health

Expedited Partner Therapy (EPT) is a practice in which a patient with an STD infection (chlamydia or gonorrhea) is given additional medication to deliver to their partner(s) without a healthcare provider first examining the partner. The Centers for Disease Control and Prevention (CDC) and The American College of Obstetricians and Gynecologists (ACOG) have indicated that EPT is effective in decreasing the rate of chlamydia and

gonorrhea reinfection and reduce the spread of disease. ACOG indicates that the 12 month reinfection rate of young women is as high as 26%, most often due to an untreated male partner. ACOG also indicates that EPT decreases reinfection rates compared to partner referrals for testing and treatment.¹ The CDC has concluded that EPT should be an option for partner treatment.² Another report by CDC concludes that the practice of EPT is cost effective saving approximately \$200 per partner treated with EPT.³ Though CDC warns of potential adverse reactions from EPT, several states with long-term EPT programs have not reported any adverse events.⁴

The Wyoming Department of Health, Communicable Disease Unit (CDU) supports the use of EPT to treat sexual partners of those infected with STDs. The CDU can provide additional resources such as partner packs which


A Quick Look at Wyomingites Who Fall into "The Medicaid Gap"



3 health centers kept track of everyone who came in for assistance with health coverage during Open Enrollment



In total they saw 351 people about their health coverage options



Of those 351 people, 32 fell into the Medicaid Gap



This averages out to about 1 in 11 people who came in for help and left with no coverage at all
